## Notes:

- 1. A permit is required for the use of a food truck as outlined in Portsmouth City Code Sec. 32 Article X and Sec. 40.2-217.
- 2. The review fee is \$50.00. The fee is NON-REFUNDABLE.
- 3. The granting of a food truck permit does not give the holder the explicit right to vend on City parcels or at City events. Vending at City events or City parcels still must be coordinated with the appropriate City department.
- 4. Each Food Truck Permit is only valid for a specific truck; permits are not transferrable to any other vehicle.
- 5. Applicants should familiarize themselves with the applicable regulations, including the Food Truck Policies and Procedures Manual. Failure to abide by the rules of the Food Truck Program may result in the revocation of the Food Truck Permit.
